# CITY OF SALEM MINUTES OF THE COMMON COUNCIL MEETING OF APRIL 4, 2016

A regular meeting of the Common Council of the City of Salem was called to order by Council President Karen Roots. The meeting took place in the Municipal Building located at 1 New Market Street at 7:00 p.m. The meeting was opened with the Pledge of Allegiance. Present: Council President Karen Roots, Councilpersons, Ruth Carter, Earl Gage, Vaughn Groce, Charles Hassler, Horace Johnson, Sharon Kellum, and Lydia Thompson. Council President announced that a quorum was present. Also in attendance were Mayor Charles Washington, Jr., Solicitor David Puma, CFO David Crescenzi and City Clerk Kathleen L. Keen.

Councilman Hassler motioned to approve an Entertainment Application for Harvest Time Worship Center to use the High School Football Field for Track and Field Events Monday through Thursday 6:00pm-8:00pm April 11 – August 31. Councilman Johnson seconded the motion. City Clerk Keen noted Council has planned to have the Circus at the football field on Monday June 27<sup>th</sup> and conveyed this to Harvest Time; they will make other arrangements for that date. Motion carried 8-0.

Solicitor Puma made a presentation to Council regarding the Salem Waterfront Condemnation Redevelopment Area. He discussed the reasons for the redevelopment plan process, and the steps the City has taken thus far, and the phases that would ensue.

### **COMMITTEE REPORTS**

Administration: President Roots reported the committee will be meeting on April 11<sup>th</sup> 8:30am at 17 New Market.

**Public Safety:** Councilman Gage acknowledged a recent email from Chief Pelura to council with regard to updating council on activities within the city. The next meeting will be April 11<sup>th</sup> 5:00pm at 17 New Market Street.

**Public Works:** Councilman Groce reported the committee met recently and discussed the possible water plant litigation.

**Human Services:** Councilman Hassler reported Future Systems will begin work in the city on April 9<sup>th</sup>; he recently attended a meeting in Trenton for the Demo Loan Fund, the loans are at 4% the city needs to narrow down the worst ten (10) properties for demolition, and complete the application as the deadline is May 9.

**City Property/Capital:** Councilwoman Carter reported she will be rescheduling the meeting originally set for April 11<sup>th.</sup>

**Redevelopment:** Councilman Groce reported the committee met and discussed the Cathedral Community Development Project, Bishop Dawn has spoken with choice, and the project could possibly be moving forward. Councilman Johnson noted Mr. Tim Gregory sent a letter to the city showing interest in a vacant property adjacent to his, Council President Roots advised the letter be forwarded to the City Property Committee.

**Neighborhood Initiatives/Community Services:** Councilwoman Thompson reported there will be a city wide spring cleanup on April 23 from 8am-noon. Everyone interested should meet at MLK Park for their location and supplies; Adopt-A-Street forms will be available also. The committee hopes to have the city pool opened this year on either June 22 or 24. Implementing a newsletter either monthly or quarterly to show the positives in the city was discussed. The next meeting will be Monday April 11, 9am at 17 New Market Street.

# **MAYORAL COMMENTS**

Mayor Washington apologized to Council for them receiving amended ordinance 1606 (Creating a Department of Commerce) late. He mentioned the Demolition Bond application and urged council to consider it, noting the 4% interest is negotiable. Lastly the Mayor Washington spoke of a meeting with Pro-Capital a lien holder in the city, and waiting for confirmation of a meeting with the Assistant Dean of Rowan.

#### **NEW BUSINESS**

Councilman Hassler reminded everyone Little League opening day is April 16<sup>th</sup> beginning at 9am. He then spoke highly of Debra Emel a 42 year city employee whom recently passed, and asked for a moment of silence in her honor; everyone in attendance stood in silence to honor Ms. Emel. Councilman Johnson then mentioned the Nelson House Washington Hall project won the NJ Futures Smart Growth Award for the best Smart growth Project in NJ for 2015.

#### **PUBLIC PORTION:**

<u>April Frank of West Side Court</u> addressed council regarding recent issues she was having with the housing authority and thanked Councilman Johnson for responding to her letter for help. She noted the issue has since been resolved, however she still has many concerns with the housing authority and asked council for help. Council President Roots asked Councilman Johnson as the liaison to the housing authority to meet with Ms. Frank and Housing Authority Director Mr. Dice to address Ms. Frank's concerns.

<u>Paul Dice - Director of the Housing Authority</u> distributed a handout to council containing graphs and charts of the Housing Authority financials, and gave a brief explanation of the information.

<u>Jennifer Wallace of Hires Avenue</u> stated she had a conversation recently with Chief Pelura regarding "j-walking" in the city; she then distributed copies of warning notices to council that the NJ State Police hand out.

<u>Lorraine Phillips of E. Broadway</u> inquired about a handicapped parking sign close to her residence, which to her knowledge was no longer needed. She asked to have it removed.

<u>Tiffany Phillips of E. Broadway</u> said she works Pats Pizzeria and is concerned for customers' safety with regard to the vacant storefront next door. (Jacks Men store) She noted glass and objects from the roof fall onto the sidewalk from the building. CFO stated it is owned by the city now, President Roots said it will be looked into.

<u>Rod Miller of W. Broadway</u> said he has questions regarding Mr. Whitney White whom the city just hired. Mayor Washington informed Mr. Miller this is a personnel issue, President Roots also stated any issues will be clarified with council. Mr. Miller then inquired about properties in the city that need to be cleaned up, and a sign that is hanging at a local liquor store that he feels is offensive. President Roots noted the Zoning Officer will look into it.

With no further requests for public comment, Councilman Hassler made a motion to close the Public Portion of the meeting. Councilman Johnson seconded the motion and all were in favor. Councilman Hassler motioned to convene into Executive Session, Councilman Johnson seconded the motion and all were in favor. The regular portion of the meeting ended at 8:10pm.
