## CITY OF SALEM RESOLUTION 2016-154

# A RESOLUTION ESTABLISHING A FAIR AND OPEN PROCESS FOR THE AWARDING OF PROFESSIONAL SERVICES CONTRACTS FOR THE CITY OF SALEM

WHEREAS, the City requires or may require the services of a Municipal Engineer, Municipal Auditor, Municipal Attorney, Bond Counsel, IT-Computer Consultant, Municipal Prosecutor, Public Defender, Financial Advisor, Labor Attorney, Grant Consultant, Brownfields Consulting Engineer, Municipal Water Engineer, Municipal Planner and Municipal Environmental/Wastewater Engineer; and

WHEREAS, retaining the services of qualified professionals for such professionals for such positions has long been exempt from "public bidding" by State Law N.J.S.A. 40A:11-5(a) due to the important policy consideration of allowing a body of elected officials to appoint candidates they deem to be most qualified and advantageous to the needs and goals of the municipality; and

**WHEREAS**, state Law N.J.S.A. 19:44A-20-5 permits municipalities to establish a "fair and open process" that allows for public solicitation of qualifications of persons interested in providing such services; and

WHEREAS, the Common Council has determined that establishing such a process protects its right to appoint the most qualified candidates while making the process more open and competitive; now therefore

**BE IT HEREBY RESOLVED** by the Common Council of the City of Salem in the County of Salem and State of New Jersey as follows:

- 1. The qualifications evaluation criteria, attached hereto as Exhibits "A through "K". is hereby adopted in accordance with <u>N.J.S.A.</u> 19:44A-20.7.
- 2. The City Clerk shall advertise a notice of solicitation of qualifications for such positions in a form substantially similar to Exhibit "A" attached hereto. The City Clerk shall publish said notice at least 10 calendar days in advance of the date set forth therein as the deadline to submit proposals.

- 3. The City Clerk shall make the necessary arrangements to publicly open and announce all proposals received. The City Clerk or her designee shall forthwith thereafter review all proposals received and transmit them to the City Council with a report and recommendations.
- 4. Award of any contracts based on the submissions received shall be made by Resolution of the City Council, after receipt of the materials from the City Clerk, at an open public meeting.

WHEREAS, NJSA 54:5-19.1 authorizes electronic tax sales pursuant to rules and regulations to be promulgated by the Director of the Division of Local Government Services, and

WHEREAS, the Director of the Division of Local Government Services has promulgated rules and regulations for pilot programs, and

WHEREAS, the Director of the Division of Local Government Services has approved NJ Tax lien Investors/Real Auction.com to conduct pilot programs, and

WHEREAS, the rules and regulations authorize a municipality to submit an application for participation in the pilot program for an electronic tax sales, and

WHEREAS, an electronic tax sale is innovative and provides a greater pool of potential lien buyers, thus creating the environment for a more complete tax sale process, and

**WHEREAS**, the City of Salem wishes to participate in the pilot program for an Electronic Tax Sale.

**NOW, THEREFORE, BE IT RESOLVED**, by the governing body of the City of Salem, in the State of New Jersey, that the Tax Collector is hereby authorized to complete an application to participate in the electronic tax sale program and submit same to the Director of the Division of Local Government Services.
