# CITY OF SALEM ORDINANCE NO. 1811

# AN ORDINANCE OF THE CITY OF SALEM AMENDING CITY CODE 225-37, SCHEDULE XI, HANDICAPPED PARKING ZONES

**WHEREAS**, the handicap parking space at 210 Church Street in the City of Salem created and authorized by Ordinance 03-03 is no longer needed because the resident at the location who needed the handicap space is no longer residing at that address.

**NOW THEREFORE BE IT ORDAINED** by the Common Council of the City of Salem, Salem County, New Jersey as follows:

- **Section 1.** Section 225-37, Schedule XI is hereby amended by deleting 210 Church Street as a location for a handicap parking space.
- **Section 2.** Signs restricting the space for handicap parking shall be removed from the location set forth above.
- **Section 3.** If a court of competent jurisdiction shall declare any section, paragraph, subsection, clause or provision of this Ordinance invalid, such decision shall not affect the validity of this Ordinance as a whole or any part thereof.
- **Section 4.** All ordinances or parts of ordinances of the City of Salem heretofore adopted that are inconsistent with any of the terms and provisions of this Ordinance are hereby repealed to the extent of any inconsistency.
- **Section 5.** This ordinance shall take effect as provided by law.

# CITY OF SALEM ORDINANCE NO. 1812

# AN ORDINANCE AMENDING THE CITY CODE OF THE CITY OF SALEM, SPECIFICALLY SECTION 130-82 ENTITLED "PROHIBITED USES"

**WHEREAS,** the Municipal Land Use Law (N.J.S.A. 40:55D-1 et. seq.) delegates to municipalities the power to zone and regulate development of property; and

**WHEREAS,** recent efforts by the Governor and New Jersey Legislature suggest that the sale and distribution of marijuana may become legal in the near future; and

**WHEREAS,** the Common Council of the City of Salem has determined that the cultivation, distribution and sale of marijuana presents particular concerns of safety, security and nuisances that arise as a result of the use of drugs; and

**WHEREAS,** the City recognizes that it is anticipated that the legalization of marijuana may provide the City with new revenue and employment; however, the safety and security of residents far outweighs the potential economic gain for the City; and

**WHEREAS,** given the small geographical area of the City, the Comprehensive Master Plan, and overwhelming security and safety concerns, there is no area of the City where the cultivation, processing, sale and/or distribution of marijuana can be safely established.

**NOW, THEREFORE BE IT ORDAINED** by the Common Council of the City of Salem, Salem County, New Jersey as follows:

**Section 1.** Chapter 130-82 of the General Zoning Regulations of the City Code entitled "Prohibited Uses" shall be amended to add an additional prohibited use/accessory uses enumerated therein to be prohibited in all zone districts enumerated as subsection C. and shall read as follows:

§ 130-82 Prohibited Uses

C. Marijuana cultivation facilities, marijuana product manufacturing facilities, marijuana testing facilities, marijuana retailers and ancillary businesses thereto are prohibited in all zone districts.

**Section 2.** The City Clerk is directed, after introduction, to submit a copy of the within Ordinance to the Planning Board of the City of Salem for its review in accordance with N.J.S.A. 40:55D-26 and 64. The Planning Board is directed to make and transmit a report to the Council within 35 days of the referral identifying any inconsistencies with the Master Plan or recommendations it deems appropriate.

The City Clerk is further directed to give notice by personal service, certified mail or email with confirmation of delivery at least ten (10) days prior the hearing on the adoption of the Ordinance to the Salem County Planning Board and Clerks of adjoining municipalities.

**Section 3.** If a court of competent jurisdiction shall declare any section, paragraph, subsection, clause or provision of this Ordinance invalid, such decision shall not affect the validity of this Ordinance as a whole or any part thereof.

**Section 4.** All ordinances or parts of ordinances of the City of Salem heretofore adopted that are inconsistent with any of the terms and provisions of this Ordinance are hereby repealed to the extent of any inconsistency.

Councilman Groce initiated for this Ordinance to be **Tabled**. Councilman Gage made the motion to table; Councilwoman Kellum seconded it; motion carried. Mayor was not expecting a vote. This Ordinance will be in review for the next Council meeting.

While it has been stated that having marijuana stores in the City could help the City financially, it is the Mayor's take that not all money is good money. We have had a high unemployment rate. I believe it is a set-up for an economically tired community and I believe the City of Salem can do better. The Mayor suggested that the legislation be read in order to be fully informed. Further elaborating, "The City of Salem would only get a small percentage associated with the sales. The state itself would be the one benefiting most of the money, therefore, leaving our municipality dealing with the consequences of having those types of establishments within our City. We have enough crime and drug usage within our City. Very quickly, what becomes legal can become illegal if not monitored properly, so I am totally against it." Concluding, for all the success stories that you hear about in Colorado, you do not hear about the accidents and such, associated with marijuana use. Please educate yourself and we will have another conversation about it in our next Council meeting. A lot of phone calls are being received of the legalization, I have no interest however, of receiving any revenue in that manner.

#### **PUBLIC PORTION**

Brian Knox - 161 W. Broadway. Ask on how he can go about getting a handicap parking for his wife and parents who are handicapped. The distance from where they park, to their apartment is difficult for his family. Complained about the trash and that he would volunteer to pick up the trash in return for a handicap parking sign. Mayor stated that the owner will be contacted in regards to the trash, but that Mr. Knox will have to speak with the owner about a parking space.

Madji Youssef – VanMeter Terrace; is concerned about the huge tax lien on his property. Does not want it to go into foreclosure. Can't pay everything; he feels he's being overcharged. Dave responded with, during the re-evaluation, it was lowered. He is too far along into foreclosure to make a deal. Cannot file an appeal without paying the taxes. Council President Roots suggested

that Mr. Youssef come into the office on Thursday, April 11, 2019 at 10 am to speak with the tax assessor.

Ms. Gilliam – 355 E. Broadway. I just moved here and I am concerned with the amount of trash I see. I have a heart for the people. I would like to volunteer to pick up trash. The home next door is trashed. I would not only like to link up with an organization, but get the community involved and be the solution. Council President Roots informed her that we do clean ups in the city throughout the year. As a clean-up day approaches, areas are being identified. She was thanked for wanting to be a solution and will be in contact with her further.

Larry Santos – 300 N. Market. Commended the Mayor on the opting out of marijuana distribution. Complained about drug usage across from the school. He spoke with officers. Also stated that half of the cameras that are displayed, do not work. He feels nothing is getting done and is ready to contact the attorney general. The Mayor suggested that he do just that; that we as a body are not making excuses, but that it also takes time.

Another concern are the repairs needed. He spoke with Ray Howard to get help with state and county for asphalt. Also, to create an ordinance that holds owners accountable to which a response was given that an ordinance is already in place. While Mr. Santos spoke extensively on these issues and concern, the Mayor responded with, issues cannot be handled tonight. Will allow Mr. Santos to come and address said issues and concerns at the next Public Safety meeting.

Almada – spoke on the shootings in our city. What are we to do if we desire to work with council. He stated that he fears for his life at times. The Mayor commended him for coming to the meeting, which is the first thing. There are many initiatives to get involved. We tried neighborhood watch, but it fizzes out when people do not volunteer. Council President Roots suggested that he use his resources with the prosecutor.

Joy Coleman – addressed the governing body in appreciation for her recognition.
