WHEREAS, according to the Continuity of Operations Plan administered by the Superior Court, Pilesgrove Joint Municipal Court will handle the day to day operations of the Salem Municipal Court on a temporary basis and it is necessary to provide a temporary Acting Municipal Court Administrator until the hiring process for the City of Salem has been conducted.

NOW, THEREFORE BE IT HEREBY RESOLVED by the Common Council of the City of Salem, County of Salem and State of New Jersey, that Deborah Scott, CMCA, is hereby appointed as temporary Acting Municipal Court Administrator of the Salem City Municipal Court in accordance with the Continuity of Operations Plan to run the daily operations of the Court until further action is taken.


Motion made by Councilman Hassler and seconded by Councilman Gage to adopt Resolution 2017-85. Roll Call. Motion carried 5-0.
