The Mayor's Message:

Since 2016 you've heard me speak with great excitement about Salem City's Commerce Department successfully recruiting Empire Blended into our city, and how our administration waited with great anticipation of the more than 100 employment opportunities for our residents and the start of our economic recovery.

Where this economic driver stands today is a top priority question the City wants to address with our citizens.

The wonderful news is that after great effort by the City, County and State, the Salem County rail line is ready to connect to the Salem Port for the first time in decades and ready to power economic revitalization in the City and region.

The sobering news is while operable, the rail line will operate with speed restrictions. Project funding delays, engineering, legal and permitting issues had left the City and County at the mercy of several new timelines causing the project to finally be completed in November of 2018, after missing multiple completion dates. There are additional assessments scheduled through 2019 to determine full operating capacity of the rail line.

Unfortunately, these delays have created economic challenges for Empire Blended as a result. The company has indicated that it may be forced to move out of the City due to the delays, and cuts to anticipated funding from state incentives. The City continues to do everything possible to encourage Empire Blended to stay in Salem, however it is a private corporate decision over which we have no control.

The Mayor and Council will continue to push our economic strategies to the best of our ability and shall keep you informed and engaged.

The City continues to wait for the legal maneuvering of foreclosure to play out so that we can facilitate negotiations with the developer and operator of our choice and Pennsville National Bank. We were able to identify a reputable operator months ago through Uplift Solutions who specialize in successfully operating grocery stores in food deserts.

The City and Uplift representatives remain in constant contact always strategizing on ways to acquire possession of the Incollingo's site. We are covering all bases and even talking with the private owners of the site to bring all parties, the bank, current ownership and Uplift to the bargaining table. As long as the site is in foreclosure the process will remain lengthy but we are not deterred.

The City remains fully committed to bringing a quality grocery store to our community and this goal remains our priority. We will continue to keep you informed of any new developments as they become available.
